- Policy Handbook of the Company comprising of various policies of the Company.
- Organizational Chart of the Company and the profile of all the Directors and the Key Managerial Personnel of the Company.
- List of Contact details of the Directors and Senior Managerial Personnel.

#### B. Initiatives to update the Independent Directors on a Continuing Basis:

- Presentations are made at the Board and Committee meetings which inter alia, cover business strategies, management structure, HR policy, management development

- The Company have prepared a booklet for Director Familiarization containing indepth information about the Company, its business, management, capital structure, promoters and promoter group, etc.
- This booklet is updated and made available to Independent Directors as and when required.
